7	WHEREAS,	the Tohono O'odham Nation Judicial Branch has prepared and submitted for
8		review and approval its FY 2017 Budget, which is incorporated by this reference,
9		in the amount of \$6,325,367.10, to be funded from the General Fund; and
10	WHEREAS,	the Judiciary and Budget and Finance Committees have reviewed the FY 2017
11		Tohono O'odham Judicial Branch Budget and recommend its approval.
12	NOW, THERE	FORE, BE IT RESOLVED the Tohono O'odham Legislative Council approves the FY
13		2017 Tohono O'odham Judicial Branch Budget, effective October 1, 2016, in the
14		amount of \$6,325,367.10, which shall be funded by the General Fund.

16		any designated official is authorized to administer and expend the FY 2017
