

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Tohono O'odham Nation Judicial Branch Budget)**

RESOLUTION NO. 16-325

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to
3 appropriate these funds for the benefit of the nation and its members" provided
4 that "[a]ll expenditures of these funds shall be pursuant to appropriations or
5 budgets" authorized by resolution or ordinance (Constitution of the Tohono
6 O'odham Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Tohono O'odham Nation Judicial Branch has prepared and submitted for
8 review and approval its FY 2017 Budget, which is incorporated by this reference,
9 in the amount of \$6,325,367.10, to be funded from the General Fund; and


10 **WHEREAS,** the Judiciary and Budget and Finance Committees have reviewed the FY 2017
11 Tohono O'odham Judicial Branch Budget and recommend its approval.

12 **NOW, THEREFORE, BE IT RESOLVED** the Tohono O'odham Legislative Council approves the FY
13 2017 Tohono O'odham Judicial Branch Budget, effective October 1, 2016, in the
14 amount of \$6,325,367.10, which shall be funded by the General Fund.

15 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Chief Judge or
16 any designated official is authorized to administer and expend the FY 2017
17 Tohono O'odham Nation Judicial Branch Budget, provided that any
18 amendments or modifications shall be submitted for prior approval by the
19 Tohono O'odham Legislative Council.

20 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 26TH
21 day of JULY, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-
22 AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by
23 Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by
24 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
25 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of
26 June 18, 1934 (48 Stat.984).
