

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Department of Health and Human Services Self-Governance Budgets)

RESOLUTION NO. 16-327

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
 2 within the exclusive control of the Tohono O'odham Nation...and to appropriate
 3 these funds for the benefit of the nation and its members" provided that "[a]ll
 4 expenditures of these funds shall be pursuant to appropriations or budgets"
 5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
 6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for
 8 review and approval its FY 2017 Department of Health and Human Services Self-
 9 Governance base budgets in the amount of \$5,584,992.00 per the following and
 10 which are incorporated by this reference:

 20 Governance saving budgets in the amount of \$2,990,376.00 per the following and

29 **WHEREAS,** the total FY 2017 Department of Health and Human Services Self-Governance
 30 base and savings budgets total \$8,575,368.00 and are to be funded from the Self-
 31 Governance Funding Agreement; and

1 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
2 **reviewed the FY 2017 Department of Health and Human Services Self-**
3 **Governance base budgets and saving budgets and recommend their approval.**

4 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
5 **the FY 2017 Department of Health and Human Services Self-Governance base**
6 **budgets and saving budgets effective October 1, 2016 in the total amount of**
7 **\$8,575,368.00, which shall be funded by the Self-Governance Funding**
8 **Agreement.**

9 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
10 **O'odham Nation's Chairperson or any designated official is authorized to**
11 **negotiate and execute amendments to the Self-Governance Funding Agreement**
12 **with the IHS for the maximum allowable funding.**

13 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
14 **O'odham Nation chairperson or any designated official is authorized to**
15 **administer and expend the FY 2017 Department of Health and Human Services**
16 **Self-Governance base budgets and saving budgets, provided that any**
17 **amendments or modification shall be submitted for prior approval by the**
18 **Tohono O'odham Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27TH**
20 **day of JULY, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**
21 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
22 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
23 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
25 **June 18, 1934 (48 Stat.984).**


