

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2017 Department of Health and Human Services, Division of Child Welfare, Title IV-B, Subparts 1 and 2 Budgets)**

**RESOLUTION NO. 16-329**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation...and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Health and Human Services, Division of Child Welfare has**  
8 **prepared and submitted for review and approval its FY 2017 Title IV-B, Subpart 1**  
9 **Budget-\$89,367.00 funded by the Stephanie Tubb Jones Child Welfare Services**  
10 **Program and Subpart 2 Budget-\$190,666.59 funded by the Promoting Safe and**  
11 **Stable Families, which are incorporated by this reference in the total amount of**  
12 **\$280,033.59; and**

13 **WHEREAS, the Health and Human Services and the Budget and Finance Committees have**  
14 **reviewed the FY 2017 Department of Health and Human Services, Division of**  
15 **Child Welfare, Title IV-B Subparts 1 and 2 Budgets and recommend their**  
16 **approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
18 **FY 2017 Department of Health and Human Services, Division of Child Welfare**  
19 **Title IV-B, Subpart Budget-\$89,367.00 which shall be funded by the Stephanie**  
20 **Tubb Jones Child Welfare Services Program and Title IV-B Subpart 2 Budget-**  
21 **\$190,666.59 which shall be funded by the Promoting Safe and Stable Families**  
22 **and effective October 1, 2016.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**  
24 **O'odham Nation chairperson or any designated official is authorized to**  
25 **administer and expend the FY 2017 Department of Health and Human Services,**  
26 **Division of Child Welfare Title IV-B, Subparts 1 and 2 Budgets, provided that any**  
27 **amendments or modifications shall be submitted for prior approval by the**  
28 **Tohono O'odham Legislative Council.**
