

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2017 Department of Health and Human Services, Division of Health**  
**Transportation Service Budget)**

**RESOLUTION NO. 16-330**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation...and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Health and Human Services, Division of Health**  
8 **Transportation Service has prepared and submitted for review and approval its**  
9 **FY 2017 Health Transportation Service Budget, which is incorporated by this**  
10 **reference, in the amount of \$3,672,314.00 to be funded by program revenue and**  
11 **the Nation's general fund; and**

12 **WHEREAS, the general fund portion of the FY 2017 Department of Health and Human**  
13 **Services, Division of Health Transportation Budget, in the amount of**  
14 **\$2,179,492.00 was approved by Resolution No. 16-322; and**

15 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**  
16 **reviewed the FY 2017 Department of Health and Human Services, Division of**  
17 **Health Transportation Service Budget and recommend its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
19 **FY 2017 Department of Health and Human Services, Division of Health**  
20 **Transportation Service Budget effective October 1, 2016, in the amount of**  
21 **\$1,492,822.00, which shall be funded by program revenue.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**  
23 **O'odham Nation chairperson or any designated official is authorized to**  
24 **administer and expend the FY 2017 Department of Health and Human Services,**  
25 **Division of Health Transportation Service Budget, provided that any**  
26 **amendments or modifications shall be submitted for prior approval by the**  
27 **Tohono O'odham Legislative Council.**
