10	•	amount of \$571,985.00 to be funded from the State of Arizona; and
11	WHEREAS,	the Health and Human Services and Budget and Finance Committees of the
12		Legislative Council have reviewed the FY 2017 Department of Health and Human
13		Services, ALTCS Budget and recommend its approval.

15		FY 2017 Department of Health and Human Services, ALTCS Budget effective
