9		its FY 2017 Enhancing HIV/AIDS Screening and Patient Navigation Project Grant
10		Budget, which is incorporated by this reference, in the amount of \$61,000.00 to
11		be funded by the project grant; and
12	WHEREAS,	the Health and Human Services and Budget and Finance Committees have
13		reviewed the FY 2017 Department of Health and Human Services, HIV/AIDS
14		Disease Intervention Surveillance Program, Enhancing HIV/AIDS Screening and
15		Patient Navigation Project Grant Budget and recommend its approval.

26		Screening and Patient Navigation Project Grant Budget, provided however, that
27		any amendments or modifications shall be submitted for prior approval by the
28		Tohono O'odham Legislative Council.
