

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Department of Health and Human Services, Food Distribution
Program, USDA Food Distribution Budget)

RESOLUTION NO. 16-333

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation...and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Health and Human Services, Food Distribution Program has**
8 **prepared and submitted for review and approval its FY 2017 United States**
9 **Department of Agriculture ("USDA") Food Distribution Budget which is**
10 **incorporated by this reference, in the amount of \$244,715.00 to be funded from**
11 **the United States Department of Agriculture; and**

12 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
13 **reviewed the FY 2017 Department of Health and Human Services, Food**
14 **Distribution Program, USDA Food Distribution Budget and recommend its**
15 **approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
17 **FY 2017 Department of Health and Human Services, Food Distribution Program,**
18 **USDA Food Distribution Budget effective October 1, 2016 in the amount of**
19 **\$244,715.00, and to utilize the Nation's resources pending reimbursement from**
20 **the grantor.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
22 **O'odham Nation chairperson or any designated official is authorized to**
23 **administer and expend the FY 2017 Department of Health and Human Services,**
24 **Food Distribution Program, USDA Food Distribution Budget, provided that any**
25 **amendments or modifications shall be submitted for approval by the Tohono**
26 **O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27TH**
28 **day of JULY, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
30 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
33 **June 18, 1934 (48 Stat.984).**
