

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Department of Health and Human Services, Food Distribution
Nutrition Education Budget)**

RESOLUTION NO. 16-334

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation...and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Health and Human Services, Food Distribution Program has**
8 **prepared and submitted for review and approval its FY 2017 Nutrition Education**
9 **Budget which is incorporated by this reference in the amount of \$2,300.00 to be**
10 **funded from the United States Department of Agriculture; and**

11 **WHEREAS, the Health and Human Services and the Budget and Finance Committees have**
12 **reviewed the FY 2017 Department of Health and Human Services, Food**
13 **Distribution Nutrition Education Budget and recommend its approval.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
15 **FY 2017 Department of Health and Human Services, Food Distribution Nutrition**
16 **Education Budget effective October 1, 2016 in the amount of \$2,300.00 and to**
17 **utilize the Nation's resources pending reimbursement from the grantor.**

18 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
19 **O'odham Nation chairperson or any designated official is authorized to**
20 **administer and expend the FY 2017 Department of Health and Human Services,**
21 **Food Distribution Nutrition Education Budget, provided that any amendments**
22 **or modifications shall be submitted for prior approval by the Tohono O'odham**
23 **Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27TH**
25 **day of JULY, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**
26 **AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by**
27 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
28 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
30 **June 18, 1934 (48 Stat.984).**
