

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Department of Health and Human Services, Division of Behavioral Health, Tas Tonlik Ki Budget)

RESOLUTION NO. 16-335

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation...and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Health and Human Services, Division of Behavioral Health,**
8 **Tas Tonlik Ki has prepared and submitted for review and approval its FY 2017**
9 **Budget, which is incorporated by this reference, in the amount of \$1,054,600.00,**
10 **to be funded from Third Party collections; and**

11 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
12 **reviewed the FY 2017 Department of Health and Human Services, Division of**
13 **Behavioral Health, Tas Tonlik Ki Budget and recommend its approval .**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
15 **FY 2017 Department of Health and Human Services, Division of Behavioral**
16 **Health, Tas Tonlik Ki Budget, effective October 1, 2016, in the amount of**
17 **\$1,054,600.00 which shall be funded by Third Party collections.**

18 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
19 **O'odham Nation chairperson or any designated official is authorized to**
20 **administer and expend the FY 2017 Department of Health and Human Services,**
21 **Division of Behavioral Health, Tas Tonlik Ki Budget, provided however, that any**
22 **amendments or modifications shall be submitted for prior approval by the**
23 **Tohono O'odham Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27TH**
25 **day of JULY, 2016 at a meeting at which a quorum was present with a vote of 2,792.8 FOR; -0-**
26 **AGAINST; 228.6 [01] NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the**
27 **Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation,**
28 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
29 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
30 **16 of the Act of June 18, 1934 (48 Stat.984).**
