

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Department of Health and Human Services, Women, Infants and Children Program, Inter Tribal Council of Arizona Grant Budget)

RESOLUTION NO. 16-336

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation...and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Health and Human Services, Women, Infants and Children**
8 **Program has prepared and submitted for review and approval its FY 2017 Inter**
9 **Tribal Council of Arizona Budget, which is incorporated by this reference, in the**
10 **amount of \$182,200.00, to be funded by the Inter Tribal Council of Arizona Grant;**
11 **and**

12 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
13 **reviewed the FY 2017 Department of Health and Human Services, Women,**
14 **Infants and Children Program, Inter Tribal Council of Arizona Grant Budget and**
15 **recommend its approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
17 **FY 2017 Department of Health and Human Services, Women, Infants and**
18 **Children Program, Inter Tribal Council of Arizona Grant Budget, in the amount**
19 **of \$182,200.00, effective October 1, 2016, and to utilize the Nation's resources**
20 **pending reimbursement from the Grantor.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
22 **O'odham Nation chairperson or any designated official is authorized to**
23 **administer and expend the FY 2017 Department of Health and Human Services,**
24 **Women, Infants and Children Program, Inter Tribal Council of Arizona Grant**
25 **Budget, that any amendments or modifications shall be submitted for prior**
26 **approval by the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27TH**
28 **day of JULY, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
30 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
33 **June 18, 1934 (48 Stat.984).**




