

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Arizona FY 2017 Department of Education, One Stop Division Bureau of Indian**  
**Affairs Public Law 102.477 Master Contract Budget)**

**RESOLUTION NO. 16-337**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation...and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Education, One Stop Division has prepared and submitted for**  
8 **review and approval its FY 2017 Department of Education, Once Stop Division**  
9 **Bureau of Indian Affairs Public Law 102.477 Master Contract Budget, which is**  
10 **incorporated by this reference, in the amount of \$1,223,708.72, to be funded by**  
11 **the Master Contract; and**

12 **WHEREAS, the Human Resources Department and Budget and Finance Committees have**  
13 **reviewed the FY 2017 Department of Education, One Stop Division Bureau of**  
14 **Indian Affairs Public Law 102.477 Master Contract Budget and recommend its**  
15 **approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
17 **FY 2017 Department of Education, One Stop Division Bureau of Indian Affairs**  
18 **Public Law 102.477 Master Contract Budget, effective October 1, 2016, in the**  
19 **amount of \$1,223,708.72, which shall be funded by the Master Contract.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**  
21 **O'odham Nation chairperson or any designated official is authorized to**  
22 **administer and expend the FY 2017 Department of Education, One Stop Division**  
23 **Bureau of Indian Affairs Public Law 102-477 Master Contract Budget, provided**  
24 **that any amendments or modifications shall be submitted for prior approval by**  
25 **the Tohono O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27<sup>TH</sup>**  
27 **day of JULY, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**  
28 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**  
29 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
30 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
32 **June 18, 1934 (48 Stat.984).**
