

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Education Department, Child Care Services Program Child
Care and Development Fund Budgets)

RESOLUTION NO. 16-338

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation...and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Education Department, Child Care Services Program has prepared and**
8 **submitted for review and approval its FY 2017 Education Department, Child**
9 **Care Services Program Child Care and Development Budgets, which are**
10 **incorporated by this reference, in the amount of \$1,179,619.00, to be funded**
11 **from the Nation's general fund; and**

12 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**
13 **reviewed the FY 2017 Education Department, Child Care Services Program Child**
14 **Care and Development Fund Budgets and recommend their approval .**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
16 **FY 2017 Education Department, Child Care Services Program Child Care and**
17 **Development Fund Discretionary Budget - \$561,733.00 and Child Care and**
18 **Development Fund Mandatory Budget - \$617,886.00 effective October 1, 2016 in**
19 **the amount of \$1,179,619.00 which shall be funded from the Nation's general**
20 **fund pending reimbursement from the Grantor.**

21 **BE IT FURTHER RESOLVED that the Education Department, Child Care Services Program Child**
22 **Care and Development Fund Budgets are authorized to utilize funding for the**
23 **two-year project period ending September 30, 2018 or until the grant funds are**
24 **fully expended to provide continued services.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
26 **O'odham Nation chairperson or any designated official is authorized to**
27 **administer and expend the FY 2017 Education Department, Child Care Services**
28 **Program Child Care and Development Fund Budgets, provided however, that**
29 **any amendments or modifications shall be submitted for further prior approval**
30 **by the Tohono O'odham Legislative Council.**
