20		fund pending reimbursement from the Grantor.

23		two-year project period ending September 30, 2018 or until the grant funds are

26		O'odham Nation chairperson or any designated official is authorized to
27		administer and expend the FY 2017 Education Department, Child Care Services

29		any amendments or modifications shall be submitted for further prior approval
30		by the Tohono O'odham Legislative Council.
