

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2017 Department of Education, Head Start Budgets)**

**RESOLUTION NO. 16-339**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation...and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Education, Division of Early Childhood Development has**  
8 **prepared and submitted for review and approval its FY 2017 Department of**  
9 **Education, Head Start Budgets, which are incorporated by this reference, in the**  
10 **amount of \$1,761,428.00, to be funded by federal funds; and**

11 **WHEREAS, the administrative cost is restricted to 15% of the total non-federal and federal**  
12 **portion of funding and the indirect cost is budgeted in the Administration**  
13 **Budget only for the Head Start Program; and**

14 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**  
15 **reviewed the FY 2017 Department of Education, Head Start Budgets and**  
16 **recommend its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
18 **FY 2017 Department of Education, Head Start Budgets, effective November 1,**  
19 **2016, in the amount of \$1,761,428.00 which shall be funded by federal funds.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**  
21 **O'odham Nation chairperson or any designated official is authorized to**  
22 **administer and expend the FY 2017 Department of Education, Head Start**  
23 **Budgets, provided however, that any amendments or modifications shall be**  
24 **submitted for prior approval by the Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27<sup>TH</sup>**  
26 **day of JULY, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**  
27 **AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**  
28 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
29 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
31 **June 18, 1934 (48 Stat.984).**
