14		reviewed the FY 2017 Education Department, Vocational Rehabilitation
15		Program Budget and recommend its approval .

17		FY 2017 Education Department, Vocational Rehabilitation Program Budget
18		effective October 1, 2016, in the amount of \$450,723.00 to be funded by the

20		requires an in-kind match in the amount of \$49,579.53 from the Tohono
21		O'odham Nation.

27		O'odham Legislative Council.
