

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Education Department, Vocational Rehabilitation Program Budget)

RESOLUTION NO. 16-341

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation...and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Education Department, Vocational Rehabilitation Program has prepared**
8 **and submitted for review and approval its FY 2017 Budget, which is incorporated**
9 **by this reference, in the amount of \$450,723.00, to be funded from the Nation's**
10 **general fund pending reimbursement from the grantor, and which requires an**
11 **in-kind match in the amount of \$49,579.53 from the Tohono O'odham Nation;**
12 **and**

13 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**
14 **reviewed the FY 2017 Education Department, Vocational Rehabilitation**
15 **Program Budget and recommend its approval .**


16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
17 **FY 2017 Education Department, Vocational Rehabilitation Program Budget**
18 **effective October 1, 2016, in the amount of \$450,723.00 to be funded by the**
19 **Nation's general fund pending reimbursement from the grantor, and which**
20 **requires an in-kind match in the amount of \$49,579.53 from the Tohono**
21 **O'odham Nation.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
23 **O'odham Nation chairperson or any designated official is authorized to**
24 **administer and expend the FY 2017 Education Department, Vocational**
25 **Rehabilitation Program Budget, provided however, that any amendments or**
26 **modifications shall be submitted for further prior approval by the Tohono**
27 **O'odham Legislative Council.**

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27TH day of JULY, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0- AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).




