

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Planning and Economic Development Department, Roads
Program Sells District Signs and Warning Lights Budget)

RESOLUTION NO. 16-342

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to
3 appropriate these funds for the benefit of the nation and its members" provided
4 that "[a]ll expenditures of these funds shall be pursuant to appropriations or
5 budgets" authorized by resolution or ordinance (Constitution of the Tohono
6 O'odham Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2017 Planning and Economic Development Department, Roads Program
8 Sells District Signs and Warning Lights Budget has prepared and submitted for
9 review and approval its FY 2017 Planning and Economic Development
10 Department, Roads Program Sells District Signs and Warning Lights Budget,
11 which is incorporated by this reference, in the amount of \$147,237.80 to be
12 funded from the Bureau of Indian Affairs; and

13 **WHEREAS,** the Agricultural and Natural Resources and Budget and Finance Committees
14 have reviewed the FY 2017 Planning and Economic Development Department,
15 Roads Program Sells District Signs and Warning Lights Budget and recommend
16 its approval.

17 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
18 FY 2017 Planning and Economic Development Department, Roads Program Sells
19 District Signs and Warning Lights Budget effective October 1, 2016 in the amount
20 of \$147,237.80, which shall be funded by the Bureau of Indian Affairs, and to
21 utilize the Nation's resources pending reimbursement from the grantor.

22 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono
23 O'odham Nation chairperson or any designated official is authorized to
24 administer and expend the FY 2017 Planning and Economic Development
25 Department, Roads Program Sells District Signs and Warning Lights Budget,
26 provided that any amendments or modifications shall be submitted for prior
27 approval by the Tohono O'odham Legislative Council.




