

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2017 Planning and Economic Development Department, Roads Program San**  
**Lucy Community Design and Construction of Sidewalks and Street Lights Budget)**

**RESOLUTION NO. 16-346**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**  
3 **appropriate these funds for the benefit of the nation and its members" provided**  
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**  
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**  
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2017 Planning and Economic Development Department, Roads Program**  
8 **has prepared and submitted for review and approval its FY 2017 San Lucy**  
9 **Community Design and Construction of Sidewalks and Street Lights Budget,**  
10 **which is incorporated by this reference, in the amount of \$186,020.29 to be**  
11 **funded from the Bureau of Indian Affairs; and**

12 **WHEREAS, the Agricultural and Natural Resources and Budget and Finance Committees**  
13 **have reviewed the FY 2017 Planning and Economic Development Department,**  
14 **Roads Program San Lucy Community Design and Construction of Sidewalks and**  
15 **Street Lights Budget and recommend its approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
17 **FY 2017 Planning and Economic Development Department, Roads Program San**  
18 **Lucy Community Design and Construction of Sidewalks and Street Lights Budget**  
19 **effective October 1, 2016 in the amount of \$186,020.29, which shall be funded by**  
20 **the Bureau of Indian Affairs, and to utilize the Nation's resources pending**  
21 **reimbursement from the grantor.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**  
23 **O'odham Nation chairperson or any designated official is authorized to**  
24 **administer and expend the FY 2017 Planning and Economic Development**  
25 **Department, Roads Program San Lucy Community Design and Construction of**  
26 **Sidewalks and Street Lights Budget, provided that any amendments or**  
27 **modifications shall be submitted for prior approval by the Tohono O'odham**  
28 **Legislative Council.**
