

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Planning and Economic Development Department, Roads Program
Preconstruction and Construction of Project PIR 101(2) Budget)

RESOLUTION NO. 16-347

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Planning and Economic Development Department, Roads Program has**
8 **prepared and submitted for review and approval its FY 2017 Preconstruction**
9 **and Construction of Project PIR 101(2) Budget, which is incorporated by this**
10 **reference, in the amount of \$2,606,815.24 to be funded from the Bureau of**
11 **Indian Affairs; and**

12 **WHEREAS, the Agricultural and Natural Resources and Budget and Finance Committees**
13 **have reviewed the FY 2017 Planning and Economic Development Department,**
14 **Roads Program Preconstruction and Construction of Project PIR 101(2) Budget**
15 **and recommend its approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
17 **FY 2017 Planning and Economic Development Department, Roads Program**
18 **Preconstruction and Construction of Project PIR 101(2) Budget effective October**
19 **1, 2016 in the amount of \$2,606,815.24, which shall be funded by the Bureau of**
20 **Indian Affairs, and to utilize the Nation's resources pending reimbursement**
21 **from the grantor.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
23 **O'odham Nation chairperson or any designated official is authorized to**
24 **administer and expend the FY 2017 Planning and Economic Development, Roads**
25 **Program Preconstruction and Construction of Project PIR 101(2) Budget,**
26 **provided that any amendments or modifications shall be submitted for prior**
27 **approval by the Tohono O'odham Legislative Council.**
