

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2017 Department of Natural Resources, Solid Waste Management**  
**Program Revenue Budget)**

**RESOLUTION NO. 16-348**

1   **WHEREAS,**    the Tohono O'odham Legislative Council is authorized "to manage any funds  
2                    within the exclusive control of the Tohono O'odham Nation . . . and to  
3                    appropriate these funds for the benefit of the nation and its members" provided  
4                    that "[a]ll expenditures of these funds shall be pursuant to appropriations or  
5                    budgets" authorized by resolution or ordinance (Constitution of the Tohono  
6                    O'odham Nation, Article VI, Section 1(d)(2)); and

7   **WHEREAS,**    the Department of Natural Resources, Solid Waste Management Program has  
8                    prepared and submitted for review and approval its FY 2017 Budget, which is  
9                    incorporated by this reference, in the amount of \$1,921,158.40 to be funded from  
10                  the general fund and program revenue; and

11 **WHEREAS,**    the general fund portion of the FY 2017 Department of Natural Resources, Solid  
12                  Waste Management Program Budget, in the amount of \$1,511,158.40 was  
13                  approved by Resolution No. 16-322; and

14 **WHEREAS,**    the Agricultural and Natural Resources and Budget and Finance Committees  
15                  have reviewed the FY 2017 Department of Natural Resources, Solid Waste  
16                  Program Budget and recommend its approval.

17 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
18                  FY 2017 Department of Natural Resources, Solid Waste Program Budget effective  
19                  October 1, 2016, in amount of \$410,000.00, which shall be funded by program  
20                  revenue.

21 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono  
22                  O'odham Nation chairperson or any designated official is authorized to  
23                  administer and expend the FY 2017 Department of Natural Resources, Solid  
24                  Waste Program Budget, provided that any amendments or modifications shall  
25                  be submitted for prior approval by the Tohono O'odham Legislative Council.

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28<sup>TH</sup>**  
27 **day of JULY, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**  
28 **AGAINST; -0- NOT VOTING; and [08] ABSENT, pursuant to the powers vested in the Council by**  
29 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
30 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
32 **June 18, 1934 (48 Stat.984).**
