

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Department of Natural Resources, Rodeo and Fair Budget,
Sponsorships, Contributions and Program Revenue)

RESOLUTION NO. 16-349

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Natural Resources, Rodeo and Fair Office has prepared and**
8 **submitted for review and approval its FY 2017 Department of Natural Resources,**
9 **Rodeo and Fair Budget, which is incorporated by this reference, in the amount**
10 **of \$315,555.09 to be funded from the Nation's general fund, sponsorships,**
11 **contributions and program revenue; and**

12 **WHEREAS, the general fund portion of the FY 2017 Department of Natural Resources, Rodeo**
13 **and Fair Budget, in the amount of \$210,555.09 was approved by Resolution No.**
14 **16-322; and**

15 **WHEREAS, the Agricultural and Natural Resources and Budget and Finance Committees**
16 **have reviewed the FY 2017 Department of Natural Resources, Rodeo and Fair**
17 **Budget and recommend its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
19 **FY 2017 Department of Natural Resources, Rodeo and Fair Budget, effective**
20 **October 1, 2016, in amount of \$105,000.00 which shall be funded by**
21 **sponsorships, contributions and program revenue.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
23 **O'odham Nation chairperson or any designated official is authorized to**
24 **administer and expend the FY 2017 Department of Natural Resources, Rodeo**
25 **and Fair Budget, provided that any amendments or modifications shall be**
26 **submitted for prior approval by the Tohono O'odham Legislative Council.**
