

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Water Resources Department, SAWRSA Budget)

RESOLUTION NO. 16-351

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Water Resources Department has prepared and submitted for review and**
8 **approval its FY 2017 Water Resources Department, Southern Arizona Water**
9 **Rights Settlement Act ("SAWRSA") Budget, which is incorporated by this**
10 **reference, in the amount of \$1,915,690.01 to be funded from the SAWRSA Trust**
11 **Fund; and**

12 **WHEREAS, the FY 2017 Water Resources Department, SAWRSA Budget provides for an in-**
13 **kind service match of \$7,105.00 to the FY 2017 Water Resources Department, EPA**
14 **Budget; and**

15 **WHEREAS, the Water Resources and Budget and Finance Committees have reviewed the FY**
16 **2017 Water Resources Department, SAWRSA Budget and recommend its**
17 **approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
19 **FY 2017 Water Resources Department, SAWRSA Budget effective October 1, 2016,**
20 **in the amount of \$1,915,690.01 which shall be funded by the SAWRSA Trust Fund.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
22 **O'odham Nation chairperson or any designated official is authorized to**
23 **administer and expend the FY 2017 Water Resources Department, SAWRSA**
24 **Budget as amended, provided however, that any amendments or modifications**
25 **shall be submitted for prior approval by the Tohono O'odham Legislative**
26 **Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH**
28 **day of JULY, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**
30 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
33 **June 18, 1934 (48 Stat.984).**
