

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2017 Department of Public Safety General Assistance Program Budget)**

**RESOLUTION NO. 16-352**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to  
3 appropriate these funds for the benefit of the nation and its members" provided  
4 that "[a]ll expenditures of these funds shall be pursuant to appropriations or  
5 budgets" authorized by resolution or ordinance (Constitution of the Tohono  
6 O'odham Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Public Safety has prepared and submitted for review and  
8 approval its FY 2017 Department of Public Safety General Assistance Program  
9 Budget, which is incorporated by this reference, in the amount of \$418,210.63 to  
10 be funded from the Indian General Assistance Program of the U.S.  
11 Environmental Protection Agency; and

12 **WHEREAS,** the Domestic Affairs and Budget and Finance Committees have reviewed the FY  
13 2017 Department of Public Safety General Assistance Program Budget and  
14 recommend its approval.

15 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
16 FY 2017 Department of Public Safety General Assistance Program Budget  
17 effective October 1, 2016, in the amount of \$418,210.63, which shall be funded by  
18 the Indian General Assistance Program of the U.S. Environmental Protection  
19 Agency.

20 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono  
21 O'odham Nation chairperson or any designated official is authorized to  
22 administer and expend the FY 2017 Department of Public Safety General  
23 Assistance Program Budget, provided that any amendments or modifications  
24 shall be submitted for prior approval by the Tohono O'odham Legislative  
25 Council.

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28<sup>TH</sup>**  
27 **day of JULY, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**  
28 **AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**  
29 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
30 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
32 **June 18, 1934 (48 Stat.984).**
