

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Department of Public Safety, Environmental Protection Office
Brownfields Program Budget)

RESOLUTION NO. 16-353

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Public Safety, Environmental Protection Office has prepared**
8 **and submitted for review and approval its FY 2017 Brownfields Budget, which is**
9 **incorporated by this reference, in the amount of \$150,000.00 to be funded by a**
10 **United States Environmental Protection Agency Assistant Agreement Grant**
11 **under the Brownfields 128(a) Tribal Response Program; and**

12 **WHEREAS, the Domestic Affairs Committee and Budget and Finance Committee have**
13 **reviewed the FY 2017 Department of Public Safety, Environmental Protection**
14 **Office Brownfields Budget and recommend its approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
16 **FY 2017 Department of Public Safety, Environmental Protection Office**
17 **Brownfields Budget effective October 1, 2016 in the amount of \$150,000.00,**
18 **which shall be funded by a United States Environmental Protection Agency**
19 **Assistant Agreement Grant under the Brownfields 128(a) Tribal Response**
20 **Program.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
22 **O'odham Nation chairperson or any designated official is authorized to**
23 **administer and expend the FY 2017 Department of Public Safety, Environmental**
24 **Protection Office Brownfields Budget, provided that any amendments or**
25 **modifications shall be submitted for prior approval by the Tohono O'odham**
26 **Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH**
28 **day of JULY, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**
30 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
33 **June 18, 1934 (48 Stat.984).**
