

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2017 Department of Public Safety, Environmental Protection**  
**Office Clean Air Act Budget)**

**RESOLUTION NO. 16-354**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**  
3 **appropriate these funds for the benefit of the nation and its members" provided**  
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**  
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**  
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Public Safety, Environmental Protection Office has prepared**  
8 **and submitted for review and approval its FY 2017 Clean Air Act Budget, which is**  
9 **incorporated by this reference, in the amount of \$199,520.10 to be funded by a**  
10 **United States Environmental Protection Agency Assistant Agreement Grant**  
11 **pursuant to Section 103 of the Clean Air Act; and**

12 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed the FY**  
13 **2017 Department of Public Safety, Environmental Protection Office Clean Air Act**  
14 **Budget and recommend its approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
16 **FY 2017 Department of Public Safety, Environmental Protection Office Clean Air**  
17 **Act Budget effective October 1, 2016 in the amount of \$199,520.10 which shall be**  
18 **funded by a United States Environmental Protection Agency Assistant**  
19 **Agreement Grant pursuant to Section 103 of the Clean Air Act.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**  
21 **O'odham Nation chairperson or any designated official is authorized to**  
22 **administer and expend the FY 2017 Department of Public Safety, Environmental**  
23 **Protection Office Clean Air Act Budget, provided that any amendments or**  
24 **modifications shall be submitted for prior approval by the Tohono O'odham**  
25 **Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28<sup>TH</sup>**  
27 **day of JULY, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**  
28 **AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**  
29 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
30 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
32 **June 18, 1934 (48 Stat.984).**
