

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Planning Department, Realty Program Land Acquisition Budget)

RESOLUTION NO. 16-357

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d) (2)); and**

7 **WHEREAS, the Planning Department, Realty Program has prepared and submitted for**
8 **review and approval its FY 2017 Land Acquisition Budget, which is incorporated**
9 **by this reference, in the amount of \$330,000.00 to be funded from the Nation's**
10 **Land Acquisition fund; and**

11 **WHEREAS, the Agricultural and Natural Resources and Budget and Finance Committees**
12 **have reviewed FY 2017 Planning Department, Realty Program Land Acquisition**
13 **Budget and recommend its approval.**


14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
15 **FY 2017 Planning Department, Realty Program Land Acquisition Budget**
16 **effective October 1, 2016 in the amount of \$330,000.00, which shall be funded by**
17 **the Nation's Land Acquisition fund.**

18 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
19 **O'odham Nation chairperson or any designated official is authorized to**
20 **administer and expend the FY 2017 Planning Department, Realty Program Land**
21 **Acquisition Budget, provided that any amendments or modifications shall be**
22 **submitted for prior approval by the Tohono O'odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH**
24 **day of JULY, 2016 at a meeting at which a quorum was present with a vote of 3,021,4 FOR; -0-**
25 **AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**
26 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
27 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
29 **June 18, 1934 (48 Stat.984).**


