

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2017 Attorney General SAWRSA Trust Fund Budget)**

**RESOLUTION NO. 16-358**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**  
3 **appropriate these funds for the benefit of the nation and its members" provided**  
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**  
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**  
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Office of Attorney General has prepared and submitted for review and**  
8 **approval its FY 2017 SAWRSA Trust Fund Budget, which is incorporated by this**  
9 **reference, in the amount of \$300,000.00 to be funded from the SAWRSA Trust**  
10 **Fund; and**

11 **WHEREAS, the Domestic Affairs, Water Resources and Budget and Finance Committees**  
12 **have reviewed the FY 2017 Office of Attorney General SAWRSA Trust Fund Budget**  
13 **and recommend its approval.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
15 **FY 2017 Office of Attorney General SAWRSA Trust Fund Budget effective October**  
16 **1, 2017 in amount of \$300,000.00, which shall be funded by the SAWRSA Trust**  
17 **Fund.**

18 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**  
19 **O'odham Nation chairperson or any designated official is authorized to**  
20 **administer and expend the FY 2017 Office of Attorney General SAWRSA Trust**  
21 **Fund Budget, provided that any amendments or modifications shall be**  
22 **submitted for prior approval by the Tohono O'odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28<sup>TH</sup>**  
24 **day of JULY, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**  
25 **AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by**  
26 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
27 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
29 **June 18, 1934 (48 Stat.984).**
