

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2017 Hewel Ni'ok's KOHN Corporation for Public Broadcasting  
Community Service Grant Budget)**

**RESOLUTION NO. 16-359**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**  
3 **appropriate these funds for the benefit of the nation and its members" provided**  
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**  
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**  
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, Hewel Ni'ok has prepared and submitted for review and approval its FY 2017**  
8 **KOHN Corporation for Public Broadcasting ("CPB") Community Service Grant**  
9 **("CSG") Budget in the amount of \$272,585.47, which is incorporated by this**  
10 **reference; and**

11 **WHEREAS, CPB CSG funding is restricted to operational support of KOHN's radio broadcast**  
12 **operations and does not provide for administrative cost rates normally applied**  
13 **to grants as indirect cost, making it necessary for the established indirect cost**  
14 **rate of the Nation to be waived for this grant; and**

15 **WHEREAS, CPB permits the Nation to record and report the total calculated administrative**  
16 **support costs provided to Hewel Ni'ok as additional non-federal financial**  
17 **support; and**

18 **WHEREAS, each CPB CSG award has an expenditure period of two years, the 2017 grant**  
19 **amount will have a grant period of October 1, 2016 through September 30, 2018,**  
20 **however, Hewel Ni'ok budgets the full amount for the current fiscal year of**  
21 **October 1, 2016 through September 30, 2017; and**

22 **WHEREAS, the Cultural Preservation and Budget and Finance Committees have reviewed**  
23 **the FY 2017 Hewel Ni'ok's KOHN CPB CSG Budget and recommend its approval.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
25 **FY 2017 Hewel Ni'ok's KOHN CPB CSG Budget in the amount of \$272,585.47**  
26 **effective October 1, 2016.**

27 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby approves the**  
28 **waiver of Indirect Costs as required by the grant, provided however, that the**  
29 **Nation shall record and report the indirect administrative support provided to**  
30 **KOHN as additional non-federal financial support as permitted by CPB.**

1 **BE IT FURTHER RESOLVED** by the Tohono O'odham Legislative Council that the Nation is  
2 authorized to record and report the indirect administrative support provided to  
3 Hewel Ni'ok for the purpose of recognizing such costs as additional non-federal  
4 financial support as permitted by CPB.

5 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono  
6 O'odham Nation Chairperson or any designated official is authorized to  
7 administer and expend the FY 2017 Hewel Ni'ok's KOHN CPB CSG Budget as  
8 amended, provided however, that any amendments or modifications shall be  
9 submitted for prior approval by the Tohono O'odham Legislative Council.

10 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28<sup>TH</sup>  
11 day of JULY, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-  
12 AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by  
13 Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by  
14 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
15 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of  
16 June 18, 1934 (48 Stat.984).
