8		budget in the total amount of \$1,812,350.00 was approved by Resolution No. 15-
9		168; and
10	WHEREAS,	the Department of Health and Human Services Management of Health has
11		prepared and submitted for review and approval its FY 2016 Budget Amendment
12		No. 1, which is incorporated by this reference and which increases and
13		decreases expenses by \$50,000.00; and
14	WHEREAS,	the FY 2016 Department of Health and Human Services Budget Amendment No. 1
15		will increase the Management of Health FY 2016 budget by \$92,144.00 from
16		\$1,812,350.00 to \$1,904,494.00; and
17	WHEREAS,	the Health and Human Services and the Budget and Finance Committees of the
18		Legislative Council have reviewed the FY 2016 Department of Health and Human
19		Services Management of Health Budget Amendment No. 1 and recommend its
20		approval.
21	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby
22		approves the FY 2016 Department of Health and Human Services, Management
23		of Health Budget Amendment No. 1, which includes a \$92,144.00 increase from
24		\$1,812,350.00 to \$1,904,494.00 that shall be funded by the Indian Health Service
25		carry forward savings.
