

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Department of Health and Human Services, "All Together We Will Do It" "We:s T-We:m am B O Ju" Project Budget)

RESOLUTION NO. 16-370

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, on September 18, 2013, the Tohono O'odham Nation was awarded the "All**
8 **Together We Will Do It" "We:s T-We:m am B O Ju" grant from the Comprehensive**
9 **Tribal Justice Systems Strategic Planning-Bureau of Justice Assistance in the**
10 **amount of \$75,000.00; and**

11 **WHEREAS, the "All Together We Will Do It" "We:s T-We:m am B O Ju" Program from the**
12 **Department of Health and Human Services has prepared and submitted for**
13 **review and approval its FY2017 Budget in the amount of \$69,931.52, to be funded**
14 **by the grant; and**

15 **WHEREAS, the Health and Human Services and the Budget and Finance Committees have**
16 **reviewed the FY 2017 Department of Health and Human Services, "All Together**
17 **We Will Do It" "We:s T-We:m am B O Ju" Project Budget and recommend its**
18 **approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
20 **FY 2017 Department of Health and Human Services, "All Together We Will Do It,"**
21 **"We:s T-We:m am B O Ju" Project Budget effective April 1, 2016 in the amount of**
22 **\$69,931.52 and to utilize the Nation's resources pending reimbursement from**
23 **the grantor.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
25 **O'odham Nation chairperson or any designated official is authorized to**
26 **administer and expend the FY 2017 Department of Health and Human Services,**
27 **"All Together We Will Do It" "We:s T-We:m am B O Ju" Budget, provided however,**
28 **that any amendments or modifications shall be submitted for prior approval by**
29 **the Tohono O'odham Legislative Council.**
