

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 16-179, "Approving Fresno Canyon Community FY 2016
Budget Amendment #1" to Correct Line Item Number)**

RESOLUTION NO. 16-371

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation...and to appropriate**
3 **these funds for the benefit of the Nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, by Resolution No. 16-179, the Legislative Council approved Fresno Canyon**
8 **Community Budget Amendment #1, which included an increase to line item**
9 **"6234 - Employer Short Term Disability"; and**

10 **WHEREAS, Resolution No. 16-179 included an incorrect line item number, contrary to the**
11 **budget presented, which included the correct line item number "6235 -**
12 **Employer Short Term Disability"; and**

13 **WHEREAS, the Budget and Finance Committee recommends amending Resolution No. 16-**
14 **179 to reflect the correct line item "6235 - Employer Short Term Disability".**

15 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that**
16 **Resolution No. 16-179, "Approving Fresno Canyon Community FY 2016 Budget**
17 **Amendment #1," is amended in part to reflect the correct line item "6235 -**
18 **Employer Short Term Disability."**

19 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council authorizes the district**
20 **chairperson and any designated official to expend and administer the budget,**
21 **provided that any modifications or amendments shall be submitted for prior**
22 **approval by the Tohono O'odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 01ST**
24 **day of AUGUST, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**
25 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
26 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
27 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
29 **June 18, 1934 (48 Stat.984).**


