

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Fresnal Canyon Community FY 2016 Budget Amendment No. 2)**

RESOLUTION NO. 16-372

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only
6 by a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council

11 ; and

12 **WHEREAS,** the FY 2016 Baboquivari District Budget in the amount of \$2,089,369.21 was
13 approved by Resolution No. 15-374, which was amended by Resolution No. 15-
14 406 for Amendment No. 1 and Resolution No. 16-011 for Amendment No. 2 and
15 Resolution No. 16-177 for Amendment No. 3 and Resolution No. 16-234
16 Amendment No. 1 for Artesia/Little Tucson Community, Resolution No. 16-235
17 for South Komelic which changed overall total for Baboquivari District to
18 \$2,187,276.10; and

19 **WHEREAS,** Amendment No. 2 will decrease line item 7500 Major Capital by \$5,000.00 and
20 increase line item 7410 RM Vehicles by \$5,000.00 and will not affect Fresnal
21 Canyon Community's FY 2016 current budget in the amount of \$239,535.54, nor
22 will affect the overall Baboquivari District FY 2016 budget of \$2,187,276.10; and

23 **WHEREAS,** the Budget and Finance Committee has reviewed Fresnal Canyon Community FY
24 2016 Budget Amendment No. 2 and recommends its approval.

25 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
26 Fresnal Canyon Community FY 2016 Budget Amendment No. 2 as attached which
27 will not affect Fresnal Canyon Community's FY 2016 current budget in the
28 amount of \$239,535.54, nor will it affect the overall Baboquivari District FY 2016
29 budget of \$2,187,276.10.

6 **day of AUGUST, 2016 at a meeting at which a quorum was present with a vote of 3,021,4 FOR; -0-**
7 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
8 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
9 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
10 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
11 **(48 Stat.984).**
