

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2016 Fire Management Program Budget Amendment No. 1)**

RESOLUTION NO. 16-374

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d) (2)); and**

7 **WHEREAS, the FY 2016 Fire Management Program Budget in the amount of \$174,752.83 was**
8 **approved by Resolution No. 15-167; and**

9 **WHEREAS, the Nation's Grants and Contracts Office has identified FY 2015 carry over**
10 **savings in the amount of \$199,460.93 for the FY 2016 Fire Management Program**
11 **Budget; and**

12 **WHEREAS, the Fire Management Program has prepared and submitted for review and**
13 **approval its FY 2016 Budget Amendment No. 1, which is incorporated by this**
14 **reference and which (1) increases Personnel Expenses in 6110 FICA and 6240**
15 **Employer Matching 401K; (2) creates new line items 6020 Over-time, 6510**
16 **Lodging, 6520 Per Diem, 7010 Program Supplies, 7015 Uniforms, 7060 Food, 7075**
17 **Fuel, 7110 Communication Expense, 7210 Dues and Subscriptions, 7305 General**
18 **Liability Insurance and 7410 RM Vehicles; and (3) increases Indirect Cost**
19 **Reimbursements; and**

20 **WHEREAS, the FY 2016 Fire Management Program Budget Amendment No. 1 will increase**
21 **the budget by \$94,529.07 and increasing the overall budget from \$174,752.83 to**
22 **\$269,281.90; and**

23 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed the FY**
24 **2016 Fire Management Program Budget Amendment No. 1 and recommend its**
25 **approval.**

26 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
27 **FY 2016 Fire Management Program Budget Amendment No. 1, as attached which**
28 **includes a \$94,529.07 increase from \$174,752.83 to \$269,281.90 that shall be**
29 **funded by carry over savings from FY 2015.**

6 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 01ST**
7 **day of AUGUST, 2016 at a meeting at which a quorum was present with a vote of 3,021,4 FOR; -0-**
8 **AGAINST; [01] NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
9 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
10 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
11 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
12 **June 18, 1934 (48 Stat.984).**


