

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2016 Gu-Vo District-Administration Budget Amendment No. 1
and Pia Oik Community Budget Amendment No. 1)**

RESOLUTION NO. 16-376

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only**
6 **by a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**
8 **O'odham Nation, and all expenditures of these funds shall be by checks**
9 **signed by such treasurer or other authorized officer and the chairman or**
10 **vice chairman of the district council.; and**

11 **WHEREAS,** the FY 2016 Gu-Vo District Budgets in the amount of \$1,772,854.69 was approved
12 by Resolution No. 15-387; and

13 **WHEREAS,** the Gu-Vo District - Administration has prepared and submitted for review and
14 approval its FY 2016 Budget Amendment No. 1, which is incorporated by this
15 reference which will modify the funding in various line items in the amount of
16 \$44,499.09 with the total funding level remaining at \$1,267,890.72; and

17 **WHEREAS,** the Gu-Vo District - Pia Oik Community has prepared and submitted for review
18 and approval its FY 2016 Budget Amendment No. 1, which is incorporated by this
19 reference, will modify the funding in various line items in the amount of
20 \$6,481.41 with the total funding level remaining at \$81,434.07; and

21 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2016 Gu-Vo District -
22 Administration and Pia Oik Community Budget Amendments No. 1 and
23 recommend its approval.

24 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
25 **FY 2016 Gu-Vo District - Administration Budget Amendment No. 1 and Pia Oik**
26 **Community Budget Amendments No. 1 as attached.**



8 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
9 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
10 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
11 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
12 **June 18, 1934 (48 Stat.984).**


