

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Authorization to Deposit Chukut Kuk District FY 2016 Mining Royalties**  
**into the District's Mining Royalty Investment Account)**

**RESOLUTION NO. 16-378**

1 **WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham**  
2 **Nation,**  
3 **No district council shall expend district funds except pursuant to budgets**  
4 **authorized under resolutions of the district council and approved by the Tohono**  
5 **O'odham Council. The management of these funds shall be only by a treasurer**  
6 **or other authorized officer of the district council who has furnished a surety**  
7 **bond satisfactory to the treasurer of the Tohono O'odham Nation, and all**  
8 **expenditures of these funds shall be by checks signed by such treasurer or other**  
9 **authorized officer and the chairman or vice chairman of the district council.**

11 **WHEREAS, Tohono O'odham Legislative Council Resolution No. 16-017 allocated an**  
12 **apportionment of FY 2016 Mining Royalties in the amount of \$115,253.30 to the**  
13 **Chukut Kuk District; and**

14 **WHEREAS, Chukut Kuk District did discuss how the funds would be used and until a budget**  
15 **is authorized, the funds will be deposited into the District's Mining Royalty**  
16 **Investment account; and**

17 **WHEREAS, the Budget and Finance Committee of the Legislative Council was notified and**  
18 **recommends approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
20 **authorizes the Chukut Kuk District Administration to deposit the FY 2016**  
21 **Mining Royalties into the District's Mining Royalties Investment Account.**

22 **BE IT FINALLY RESOLVED that funds will not be expended until a budget has been authorized**  
23 **by the Tohono O'odham Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 02<sup>ND</sup>**  
25 **day of AUGUST, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**  
26 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
27 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
28 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
30 **June 18, 1934 (48 Stat.984).**
