8		Revenue Account for the deposit of generated revenues including donations and
9		contributions received; and
10	WHEREAS,	during fiscal years 2013, 2014, and 2015 Hewel Ni'ok received underwriting and
11		service revenues and \$4,630.69 of these funds remain unobligated; and
12	WHEREAS,	Hewel Ni'ok has prepared and submitted for review and approval its FY 2016
13		Hewel Ni'ok Dedicated Revenue Budget, which is incorporated by this reference,
14		in the amount of \$4,630.69 to be funded from the Dedicated Revenue Account;

16	WHEREAS,	the Cultural Preservation and the Budget and Finance Committees have
17		reviewed the FY 2016 Hewel Ni'ok Dedicated Revenue Budget and recommend its
18		approval.
19	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
20		FY 2016 Hewel Ni'ok Dedicated Revenue Budget in the amount of \$4,630.69, as
21		attached which shall be funded from the Dedicated Revenue Account.

23		O'odham Nation chairperson or any designated official is authorized to
24		administer and expend the FY 2016 Hewel Ni'ok Dedicated Revenue Budget,
