

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2016 Miss Tohono O'odham Nation Budget Amendment No. 1)**

RESOLUTION NO. 16-380

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2016 Miss Tohono O'odham Nation in the amount of \$57,800.40 was**
8 **approved by Resolution No. 15-165; and**

9 **WHEREAS, the Miss Tohono O'odham Nation has prepared and submitted for review and**
10 **approval its FY 2016 Budget Amendment No. 1, which is incorporated by this**
11 **reference and which (1) increases and decreases operational expense line items;**
12 **and (2) decreases personnel expense 6110 FICA; and**

13 **WHEREAS, the FY 2016 Miss Tohono O'odham Nation Budget Amendment No. 1 will not**
14 **change the original budgeted amount; and**

15 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**
16 **reviewed the FY 2016 Miss Tohono O'odham Nation Budget Amendment No. 1**
17 **and recommend its approval.**


18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
19 **FY 2016 Miss Tohono O'odham Nation Budget Amendment No. 1 as attached.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
21 **O'odham Nation chairperson or any designated official is authorized to**
22 **administer and expend the FY 2016 Miss Tohono O'odham Nation Budget as**
23 **amended, provided however, that any amendments or modifications shall be**
24 **submitted for prior approval by the Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 02ND**
26 **day of AUGUST, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**
27 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
28 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
29 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
31 **June 18, 1934 (48 Stat.984).**






