5		budgets" authorized by resolution or ordinance (Constitution of the Tohono
6		O'odham Nation, Article VI, Section 1(d)(2)); and
7	WHEREAS,	the FY 2016 Miss Tohono O'odham Nation in the amount of \$57,800.40 was
8		approved by Resolution No. 15-165; and
9	WHEREAS,	the Miss Tohono O'odham Nation has prepared and submitted for review and
10		approval its FY 2016 Budget Amendment No. 1, which is incorporated by this
11		reference and which (1) increases and decreases operational expense line items;
12		and (2) decreases personnel expense 6110 FICA; and
13	WHEREAS,	the FY 2016 Miss Tohono O'odham Nation Budget Amendment No. 1 will not
14		change the original budgeted amount; and
15	WHEREAS,	the Human Resources Development and Budget and Finance Committees have
16		reviewed the FY 2016 Miss Tohono O'odham Nation Budget Amendment No. 1
17		and recommend its approval.
18	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
19		FY 2016 Miss Tohono O'odham Nation Budget Amendment No. 1 as attached.
20	BE IT FINAL	LY RESOLVED by the Tohono O'odham Legislative Council that the Tohono
21		O'odham Nation chairperson or any designated official is authorized to
22		administer and expend the FY 2016 Miss Tohono O'odham Nation Budget as
23		amended, provided however, that any amendments or modifications shall be
24		submitted for prior approval by the Tohono O'odham Legislative Council.
