

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the Renewal and Amendment No. 1 of the Intergovernmental Agreement for
Law Enforcement Services between the City of Tolleson and the Tohono O'odham Nation)

RESOLUTION NO. 16-381

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "consult,**
2 **negotiate and conclude agreements and contracts on behalf of the Tohono**
3 **O'odham Nation ("Nation") with the Federal, State, and local governments..."**
4 **(Constitution of the Tohono O'odham Nation, Article VI, Section 1(f)); and**

5 **WHEREAS, the Legislative Council previously approved an Intergovernmental Agreement**
6 **for Law Enforcement Services between the City of Tolleson and the Tohono**
7 **O'odham Nation by Resolution No. 15-483; and**

8 **WHEREAS, the Nation desires to renew the Intergovernmental Agreement with the City of**
9 **Tolleson, for a term of July 1, 2016 – June 30, 2017, to aid in the various police**
10 **services identified in the Intergovernmental Agreement; and**

11 **WHEREAS, the parties desire to amend the Intergovernmental Agreement to include**
12 **property and evidence services, delivery services and training; and**

13 **WHEREAS, the fee to be paid to the City of Tolleson for their services will increase to**
14 **\$8,750.00 per month starting July 1, 2016; and**

15 **WHEREAS, the Domestic Affairs and Budget and Finance Committees of the Legislative**
16 **Council have reviewed this Renewal and Amendment No. 1 of the**
17 **Intergovernmental Agreement for Law Enforcement Services and recommend**
18 **its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it**
20 **approves the Renewal and Amendment No. 1 of the Intergovernmental**
21 **Agreement for Law Enforcement Services.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes**
23 **the Chairman of the Nation to execute the Renewal and Amendment No. 1 of the**
24 **Intergovernmental Agreement for Law Enforcement Services, provided that any**
25 **amendments shall be submitted for further prior approval by the Tohono**
26 **O'odham Legislative Council.**
