5		of committees, boards, officers and agents" (Constitution of the Tohono
6		O'odham Nation, Article VI, Section 1(c)(2) and Section 1(b)); and
7	WHEREAS,	Article V, Section 1(a) of 18 Tohono O'odham Code Chapter 1 "Tohono O'odham
8		Ki:Ki Association Ordinance," (Ordinance No. 98-03, as amended), provides that:
9		The Board shall consist of five (5) voting members appointed by the
10		Tohono O'odham Legislative Council The Board members' shall serve
11		for a period of four (4) years, or until their successors are appointed;
12		provided, however, that appointments to the Board shall be staggered in
13		such a way that the terms of office of no more than two members end in a
14		single year. The Legislative Council may appoint no more than five (5)
15		Board members to a single term of more or less than four (4) years for the
16		limited purpose of implementing the staggered term system. Thereafter,
17		all Board members' terms shall commence on March 1 and end on the
18		last day of February.

20	WHEREAS,	since February 29, 2016, members of the TOKA Board continue to serve until
21		their successors are appointed and the Housing Committee has actively
22		searched for interested TOKA Board of Directors candidates; and
23	WHEREAS,	TOKA Board of Directors candidate Mildred D. Manuel has submitted all
24		required background information, agreed to a background investigation report,
25		and interviewed with the Housing Committee; and
26	WHEREAS,	the Housing Committee recommends that Mildred D. Manuel be appointed to
27		the TOKA Board of Directors for a term beginning on the effective date of this
28		resolution and expiring February 29, 2020 or until her successor is appointed;
