| 13 | WHEREAS, | in order to implement the Nation's proposal, the Bureau of Reclamation and the |
| 14 | | Nation have negotiated an agreement, called the System Conservation |
| 15 | | Implementation Agreement ("SCIA") Between the United States Bureau of |
| 16 | | Reclamation and the Tohono O'odham Nation to Implement a Pilot System |

| 18 | WHEREAS, | the Nation previously approved a SCIA for calendar year 2015 by Resolution No. |
