1	WHEREAS,	the Tohono O'odham Legislative Council is authorized "to manage any funds
2		within the exclusive control of the Tohono O'odham Nation and to
3		appropriate these funds for the benefit of the nation and its members" provided
4		that "[a]ll expenditures of these funds shall be pursuant to appropriations or
5		budgets" authorized by resolution or ordinance (Constitution of the Tohono
6		O'odham Nation, Article VI, Section 1(d)(2)); and
7	WHEREAS,	the FY 2016 Tohono O'odham Gaming Office Budget in the amount of
8		\$4,665,408.85 was approved by Resolution No. 15-165; and
9	WHEREAS,	the Tohono O'odham Gaming Office has prepared and submitted for review and
10		approval its FY 2016 Budget Amendment No. 1, which is incorporated by this
11		reference and which (1) increases expenses in Personnel expenses; and (2) shifts
12		operational dollars within line items; and
13	WHEREAS,	the FY 2016 Tohono O'odham Gaming Office Budget Amendment No. 1 will
14		increase the Tohono O'odham Gaming Office Budget by \$30,724.08 from
15		\$4,665,408.85 to \$4,696,132.93; and
16	WHEREAS,	the Commerce and Budget Finance Committees have reviewed the FY 2016
17	i	Tohono O'odham Gaming Office Budget Amendment No. 1 and recommend its
18		approval.
19	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
20		FY 2016 Tohono O'odham Gaming Office Budget Amendment No. 1 effective
21		October 1, 2016, which includes a \$30,724.08 increase from \$4,665,408.85 to
22		\$4,696,132.93 that shall be funded by the Nation's general fund.
23	BE IT FINAL	LLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono
24		O'odham Nation chairperson or any designated official is authorized to
25	:	administer and expend the FY 2016 Tohono O'odham Gaming Office Budget as
26		amended, provided however, that any amendments or modifications shall be
27		submitted for prior approval by the Tohono O'odham Legislative Council.
