

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2016 Sif Oidak District One-Time Purchase of Canopies Budget)

RESOLUTION NO. 16-393

1 **WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham**
2 **Nation, No district council shall expend district funds except pursuant to**
3 **budgets authorized under resolutions of the district council and approved by**
4 **the Tohono O'odham Council. The management of these funds shall be only by a**
5 **treasurer or other authorized officer of the district council who has furnished a**
6 **surety bond satisfactory to the treasurer of the Tohono O'odham Nation, and all**
7 **expenditures of these funds shall be by checks signed by such treasurer or other**
8 **authorized officer and the Chairman or Vice chairman of the district council;**
9 **and**

10 **WHEREAS, the Sif Oidak District Council has prepared and acquired approval of the**
11 **attached FY 2016 Sif Oidak District One-Time Purchase of Canopies Budget**
12 **which will be funded from the Sif Oidak District operating account; and**

13 **WHEREAS, the Budget and Finance Committee did review the Budget and recommends**
14 **approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
16 **the FY 2016 Sif Oidak District One-Time Purchase of Canopies Budget as**
17 **attached and will be funded from the Sif Oidak District operating account.**

18 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
19 **District Chairperson and any designated official to expend and administer the**
20 **budget, provided that any modifications or amendments shall be submitted for**
21 **prior approval by the Tohono O'odham Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH**
23 **day of AUGUST, 2016 at a meeting at which a quorum was present with a vote of 3,021,4 FOR; -0-**
24 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
25 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**
26 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
28 **June 18, 1934 (48 Stat.984).**
