10		approval its FY 2016 Budget Amendment No. 3, which is incorporated by this
11		reference and which will adjust operational and personnel line items; and
12	WHEREAS,	the FY 2016 Department of Public Safety Tribal Law Enforcement Budget
13		Amendment No. 3 will not change the budget amount approved by Resolution No.
14		15-359 of \$7, <del>44</del> 9,628.28; and
15	WHEREAS,	the Domestic Affairs and Budget and Finance Committees have reviewed the FY
16		2016 Department of Public Safety Tribal Law Enforcement Budget Amendment
17		No. 3 and recommend its approval.
