

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 First Things First-Special Needs Program Budget)**

RESOLUTION NO. 16-415

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2); and**

7 **WHEREAS, the First Things First-Special Needs Program has prepared and submitted for**
8 **review and approval its FY 2017 First Things First-Special Needs Grant Budget in**
9 **the amount of \$225,000.00 which is incorporated by this reference, to be funded**
10 **from the grant; and**

11 **WHEREAS, the Health and Human Services and the Budget and Finance Committees have**
12 **reviewed the FY 2017 First Things First-Special Needs Program Budget and**
13 **recommend its approval.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
15 **FY 2017 First Things First-Special Needs Program Budget effective July 1, 2016 in**
16 **the amount of \$225,000.00, and to utilize the Nation's resources pending**
17 **reimbursement from the grantor.**

18 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
19 **Nation chairperson or any designated official is authorized to administer and**
20 **expend the FY 2017 First Things First-Special Needs Program Budget, provided**
21 **however, that any amendments or modifications shall be submitted for prior**
22 **approval by the Tohono O'odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22ND day**
24 **of AUGUST, 2016 at a meeting at which a quorum was present with a vote of 2,792.8 FOR; -0-**
25 **AGAINST; -0- NOT VOTING; and 228.6[11] ABSENT, pursuant to the powers vested in the Council**
26 **by Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted**
27 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
28 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
29 **Act of June 18, 1934 (48 Stat.984).**
