

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2016 San Lucy District Budget Amendment No. 1)**

**RESOLUTION NO. ~~16-418~~**

1 **WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham**  
2 **Nation,**

3 **No district council shall expend district funds except pursuant to budgets**  
4 **authorized under resolutions of the district council and approved by the**  
5 **Tohono O'odham Council. The management of these funds shall be only**  
6 **by a treasurer or other authorized officer of the district council who has**  
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**  
8 **O'odham Nation, and all expenditures of these funds shall be by checks**  
9 **signed by such treasurer or other authorized officer and the chairman or**  
10 **vice chairman of the district council.**

12 **WHEREAS, the FY 2016 San Lucy District Budget in the amount of \$1,942,071.20 was**  
13 **authorized by San Lucy District Council Resolution No. SL 10-104-15 and approved**  
14 **by Legislative Council Resolution No. 15-415; and**

15 **WHEREAS, San Lucy District has prepared and submitted for review and approval its FY 2016**  
16 **San Lucy District Budget Amendment No. 1, which is incorporated by this**  
17 **reference and was approved by San Lucy District Council Resolution No. 07-57-16**  
18 **which increases:**

1 **BE IT FURTHER RESOLVED** that Amendment No. 1 will increase the FY 2016 San Lucy District  
2 Budget by \$80,266.72 for a new total budget of \$2,022,337.92 to be funded from the  
3 lease revenues from the Desert Diamond Casino – West Valley Resort.

4 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2016 San Lucy  
5 District Budget as amended shall be managed and expended in accordance with  
6 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the  
7 Nation's laws, provided that any amendments or modifications shall be  
8 authorized under District Council resolution and submitted for prior approval by  
9 the Tohono O'odham Legislative Council.

10 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22<sup>ND</sup> day  
11 of AUGUST, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-  
12 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by  
13 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono  
14 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
15 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934  
16 (48 Stat.984).
