

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Legislative Branch FY 2016-FY 2017 Magdalena Visitor Center
Project Budget)**

RESOLUTION NO. 16-422

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council**
2 **with the authority "to manage any funds within the exclusive control of the**
3 **Tohono O'odham Nation . . . and to appropriate these funds for the benefit of the**
4 **Nation and its members "provided that" [a]ll expenditures of these funds shall**
5 **be pursuant to appropriations or budgets" authorized by resolution or**
6 **ordinance (Constitution of the Tohono O'odham Nation, Article VI, Section**
7 **1(d)(2)); and**

8 **WHEREAS, by Resolution No. 15-326, the Tohono O'odham Legislative Council approved the**
9 **FY 2016 Magdalena Visitor Center Project Budget to fund the Magdalena Visitor**
10 **Center for 2016; and**

11 **WHEREAS, the Legislative Branch will again operate the Magdalena Visitor Center for 2016**
12 **with volunteers and occasional appointments for the upcoming pilgrimage, and**
13 **accordingly has drafted the Legislative Branch FY 2016-FY 2017 Magdalena**
14 **Visitor Center Project Budget and recommend its approval; and**

15 **WHEREAS, the Cultural Preservation and the Budget and Finance Committees have**
16 **reviewed the Legislative Branch FY 2016-FY 2017 Magdalena Visitor Center**
17 **Project Budget 2016 and recommends its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
19 **and authorizes expenditures of the Legislative Branch FY 2016-FY 2017**
20 **Magdalena Visitor Center Project Budget in the amount of \$11,500.00, as per the**
21 **attached budget, beginning August 1, 2016 and ending September 30, 2017,**
22 **which shall be funded by the Nation's FY 2016 general fund surplus.**

23 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
24 **Chairperson and any designated official to expend and administer the Budget as**
25 **attached, provided that any Amendments/Modifications affecting the funds or**
26 **funding level is submitted for further prior approval by the Tohono O'odham**
27 **Legislative Council.**






