

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2016 Pisinemo Community Budget Amendment No. 3)**

**RESOLUTION NO. 16-424**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation,  
3 No district council shall expend district funds except pursuant to budgets  
4 authorized under resolutions of the district council and approved by the Tohono  
5 O'odham Council. The management of these funds shall be only by a treasurer  
6 or other authorized officer of the district council who has furnished a surety  
7 bond satisfactory to the treasurer of the Tohono O'odham Nation, and all  
8 expenditures of these funds shall be by checks signed by such treasurer or other  
9 authorized officer and the chairman or vice chairman of the district council.

11 **WHEREAS,** the FY 2016 Pisinemo District Budgets were approved by Tohono O'odham  
12 Legislative Council Resolution No. 15-378 in the amount of \$1,615,811.13; and

13 **WHEREAS,** the approved FY 2016 Pisinemo District Budgets included a budget for Pisinemo  
14 Community in the amount of \$24,500.00 which was amended by Pisinemo  
15 Community Resolution No. 16-P-05 and Legislative Council Resolution No. 15-  
16 438 for Amendment No. 1; and by Pisinemo Community Resolution No. 16-P-15  
17 and Legislative Council Resolution No. 16-134 for Amendment No. 2; and

18 **WHEREAS,** by Pisinemo District Council Resolution No. 16-P-26 the Pisinemo District has  
19 prepared and submitted for review and approval its FY 2016 Pisinemo  
20 Community Budget Amendment No. 3 which is incorporated by this reference  
21 and which (1) increases and decreases Operational Line Items; and (2) adds new  
22 language to Line Item 810-Professional Services; and

23 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2016 Pisinemo  
24 Community Budget Amendment No. 3 and recommends its approval.

25 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
26 **FY 2016 Pisinemo Community Budget Amendment No. 3 as attached.**

27 **BE IT FURTHER RESOLVED** that this amendment will add new language to Line Item 810-  
28 Professional Services and it will not change the original budgeted amount of  
29 \$24,500.00 of the FY 2016 Pisinemo Community Budget nor will it change the  
30 overall budgeted amount for the FY 2016 Pisinemo District Budget of  
31 \$1,615,811.13.

1 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2016  
2 Pisinemo Community Budget Amendment No. 3 as amended shall be managed  
3 and expended in accordance with Article IX, Section 7 of the Constitution of the  
4 Tohono O'odham Nation and the Nation's laws, provided that any amendments  
5 or modifications shall be authorized under District Council resolution and  
6 submitted for prior approval by the Tohono O'odham Legislative Council.

7 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup>  
8 day of SEPTEMBER, 2016 at a meeting at which a quorum was present with a vote of 2,521.7  
9 FOR; 132.5 AGAINST; [01] NOT VOTING; and 367.2[07] ABSENT, pursuant to the powers vested in  
10 the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted  
11 by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy  
12 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the  
13 Act of June 18, 1934 (48 Stat.984).
