

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2016 Planning Department, Roads Program Discretionary Funds
Budget Amendment No. 2)**

RESOLUTION NO. 16-426

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2016 Planning Department, Roads Program Discretionary Funds Budget**
8 **Amendment No. 1 in the amount of \$220,910.05 was approved by Resolution No.**
9 **16-046; and**

10 **WHEREAS, the Planning Department, Roads Program has prepared and submitted for**
11 **review and approval its FY 2016 Planning Department, Roads Discretionary**
12 **Fund Budget Amendment No. 2, which is incorporated by this reference and**
13 **which will adjust operational and personnel line items; and**

14 **WHEREAS, the FY 2016 Planning Department, Roads Program Discretionary Funds Budget**
15 **Amendment No. 2 will not change the Planning Department, Roads Program**
16 **Discretionary Funds Budget amount of \$220,910.05; and**

17 **WHEREAS, the Agricultural and Natural Resources and Budget and Finance Committees**
18 **have reviewed the FY 2016 Planning Department, Roads Program Discretionary**
19 **Funds Budget Amendment No. 2 and recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **FY 2016 Planning Department, Roads Program Discretionary Funds Budget**
22 **Amendment No. 2 with no change to the total budget of \$220,910.05 approved by**
23 **Resolution No. 16-046 that shall be funded by the Bureau of Indian Affairs.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
25 **O'odham Nation chairperson or any designated official is authorized to**
26 **administer and expend the FY 2016 Planning Department, Roads Program**
27 **Discretionary Funds Budget as amended, provided however, that any**
28 **amendments or modifications shall be submitted for prior approval by the**
29 **Tohono O'odham Legislative Council.**
